XL Insurance is implementing a new claim system to provide faster, more efficient service. The system is being implemented globally and the next release is planned for November.

### OUR NEW PAPERLESS CLAIMS ENVIRONMENT

As we transition to a new claims system, we also will move to a paperless claims environment. This means that all future claims-related documentation will be maintained electronically. Our preference will be to receive and deliver correspondence via email. The new email addresses for claims can be found in the chart on page 2.

We realize that you may still need to send us hard copy mail, so we have set up a new address for correspondence as well. Upon arrival at this new address, your correspondence will be scanned to create electronic documents for the new paperless environment. Please see the "New Mailing Address" section below.

### EFFECTIVE DATES AND NEW EMAIL ADDRESSES

Use of the email addresses and new postal address for claims correspondence will become effective over the next few months as each of our claims units goes paperless. Effective dates for these changes and the new email addresses can be found in the chart on page 2.
